PARTICIPATION WAIVER AGREEMENT

PLEASE READ THIS DOCUMENT (THE “WAIVER AGREEMENT”) CAREFULLY BEFORE SIGNING. THIS WAIVER AGREEMENT WILL AFFECT YOUR LEGAL RIGHTS AND WILL LIMIT OR ELIMINATE YOUR ABILITY TO BRING A FUTURE LAWSUIT.

I know that running and walking are potentially hazardous activities. I should not enter and run or walk unless I am medically able and properly trained. I agree to abide by any decision of a race official relative to my ability to safely complete the run or walk. I hereby certify that I am in good health and I have trained to run or walk the distance of the race, which I am entering. I assume all risks associated with running in this event including, but not limited to: falls, contact with other participants, the effects of weather, including high heat and/or humidity, snow, ice, slush, traffic and the conditions of the road, all such risk being know and appreciated by me. I authorize medical treatment deemed advisable by any licensed health care provider including but not limited to emergency medical volunteers. I understand that no accident or medical insurance for participants is provided and that I am financially responsible for all medical charges. Having read this waiver and knowing these facts on my behalf, I waive and release the Cider Run Planning Committee, the Susquehanna Society for the Prevention of Cruelty to Animals, its officers, directors, agents, volunteers, employees, all states, cities, counties or other governmental bodies or locations in which events or segments of events are held, the Fly Creek Cider Mill & Orchard, Inc. and the Otsego Apple Growers LLC, all sponsors, all vendors, all facility hosts, their representatives and successors, from all claims or liabilities of any kind arising out of my participation in this event even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. I grant permission to all of the foregoing to use my photographs, motion pictures, recordings, or any other record of this event for any legitimate purpose. I understand that bicycles, skateboards, roller skates or inline skates are not allowed in the event and I will abide by this guideline. I am aware that the Cider Run Planning Committee, the Susquehanna Society for the Prevention of Cruelty to Animals, the Fly Creek Cider Mill & Orchard, Inc. and the Otsego Apple Growers LLC strongly discourage the use of personal audio devises (iPods and MP3 Headsets).

I give my permission for medical release should I be involved in any accident or health –damaging situation or should I require a form of medical treatment.
